# Seven Lincoln County, SD Registered Voters Filed A Complaint Today with the Lincoln County State's Attorney Thomas Wollman, Against Commission Chairman Mike Poppens.

**Canton, SD** • Seven Lincoln County registered voters filed a complaint today with Lincoln County State's Attorney Thomas Wollman, against Michael Poppens, Chairman of the Lincoln County Commissioners.

Statements from the Lincoln County Equalization Director and the Minnehaha County Equalization Director indicate that from August 30, 2019 through October 9, 2020, Michael Poppens has declared two residences (owned as joint tenants) his 'Owner Occupied Principal Residence.' See attached documents.

Such declarations qualify taxpayers for reduced tax rates on their residences. But SDCL §10-13-39 says "a person may only have one dwelling" classified as Owner Occupied.

We are requesting State's Attorney Wollman investigate where Poppens lived during this time and where he lives today. Once this determination is made we ask him to take whatever criminal or civil action South Dakota authorizes to collect the back taxes due to Lincoln County or else, refer this to the Minnehaha County State's Attorney to provide them the opportunity to collect property taxes Poppens lawfully owes their county.

This matter is aggravated by a greater expectation of Poppens' knowledge of the property tax laws on one's 'Principal Residence' in conjunction with his duties as Chairman of the Lincoln County Commissioners.

We also ask Wollman to publish his findings as to where Poppens dwells at this time.

Lincoln County citizens will be raising objections to this during public comment time at tomorrow's scheduled Commission meeting.

**Re:** Complaint filed with Lincoln County State's Attorney, Thomas Wollman, to formally investigate Lincoln County Commissioner Mike Poppens claiming two Owner Occupied Residences.

Dear State's Attorney Wollman;

We the undersigned, as registered voters of Lincoln County, SD, request that you as Lincoln County State's Attomey, investigate Mike Poppens, Lincoln County District 4 Commissioner; to determine if from August 30, 2019 through October 9, 2020, Poppens has personally profited from reduced property taxes by simultaneously declaring separate residences - one in Lincoln County and one in Minnehaha County - his 'Owner Occupied Principal Residence'; and to determine if his Principal Residence is now in Minnehaha County.

South Dakota residents qualify for lower tax rates on their residence by signing a Certificate of Real Estate Valuation (CREV) at the time of purchase (SDCL § 10-13-40) where they certify it is their "Principal Residence" and claim their Owner Occupied reduced tax rate. SDCL §10-13-39 says "a person may only have one dwelling" classified as Owner Occupied.

On September 6, 2019, a deed was recorded (Book 591 Page 439) at the Minnehaha County Register of Deeds for a home purchased by Michael E. & Janae L. Poppens on August 30, 2019, located at 2913 S Ridgeview Way in Sioux Falls (north of O'Gorman high school). His wife signed the CREV for them (as joint tenant title holders) declaring this property their Principal Residence and qualifying for Owner Occupied status and the lower tax rate.

On December 21, 2020, Lincoln County Director of Equalization, Karla Goosman notified David Tuntland Executive Director of the Lincoln County Citizens for Real Progress Committee (Non-Profit) that, "The property located at 545 W 5th Street, Tea, SD owned by Michael Poppens did receive the owner occupied status for the 2020 assessment year.....The eligibility for owner occupied was met by Mr. Poppens November 1, 2012...Once eligibility is met, the property retains the classification until it is transferred or has a change in use (see SDCL 10-13-40). On October 9, 2020, Mr. Teng purchased the [sic. Tea] property...." from Poppens.

On December 18, 2020, two months after the sale of Poppens' Tea residence Minnehaha County Director of Equalization, Chris Lilla, notified Executive Director Tuntland, that 'he [Lilla] contacted Lincoln County to check if Poppens was receiving owner occupied status there, and they verified he was not. So in this case, his CREV is honored here [sic. in Minnehaha County].'

To summarize, from the time of the Sioux Falls home purchase on August 30, 2019, through the sale of their home in Tea on October 9, 2020, Commissioner Michael Poppens was declaring two homes his Principal Residence and qualifying for tax savings on both due to their Owner Occupied declaration. This matter is aggravated by a much greater expectation of Poppens' knowledge of the property tax laws on one's 'Principal Residence' in conjunction with his duties as Chairman of the Lincoln County Commissioners.

We now request State's Attorney Wollman investigate the conduct of Mr. Poppens. If it is found he does live in Sioux Falls (Minnehaha County), then determine if any South Dakota criminal or civil statutes have been broken. If so found, we request Wollman act to collect any lost tax revenue which Poppens denied Lincoln County, plus interest, penalties and any possible court costs, be they civil or criminal in nature.

We also request that you report back to us the findings of your investigation, including where Wollman dwells today. PoPPENS

#### Mr. Tuntland,

The property located at 545 W 5<sup>th</sup> Street, Tea, SD owned by Michael Poppens did receive the owner occupied status for the 2020 assessment year therefore will be taxed at the owner occupied rate for 2020 pay 2021.

The eligibility for owner occupied was met by Mr. Poppens November 1, 2012 for the 2013 assessment year. Once eligibility is met, the property retains the classification until it is transferred or has a change in use (see SDCL 10-13-40).

On October 9, 2020 Mr. Teng purchased the property and has submitted his owner occupied status effective for the 2021 assessment year.
